## Steps to Making and Testing Videos

- 1. Ask your community to suggest a topic.
- 2. Write a script with pictures and movement.
- 3. Create a series of visual images with text.
- 4. Record voice-over narration.
- 5. Edit audio tracks and visual images in an editing program.
- 6. Show the draft video to a community group and listen up!
- 7. Change the video based on the community feedback.
