
# Data Sharing Platforms for Legal Services



#### How it's built

- Virtru Zero Trust Architecture
  - o Ensures separation of keys and content at all times
  - o Virtru does not have access to keys or the ability to decrypt content
  - Authenticated with existing email credentials
  - Split knowledge architecture stores encrypted content separately from the encryption keys to protect sensitive data
- 4 Components
  - Virtual client libraries
  - Access Control Management Server
  - Object stores that hold encrypted content
  - Receiving clients




